Where is Pacific Tank Lines Headed?





STAYING COMPLIANT

The Compliance Department ensures that all drivers stay compliant with their driving records for 160+ drivers. In an effort to help the driver be compliant, Pacific Tank Lines has recently integrated PeopleNet which is an onboard computer and communications system. Our support team has been trained to use the system and stay compliant.

TSA Process:

Since the process can take up to 6 weeks; it is recommended that you start the process a month prior to the expiration. Once you start the process you may receive a notification from TSA, but this letter is a courtesy communication, and is not accepted as proof of a valid security threat assessment by any state.

Pacific Tank Lines requires an updated H6 showing the new expiration date. This is so we can update your expirations in all systems and with needed racks. Once you receive your updated H6 you can fax it directly to the Compliance Department at 951-823-5468.

If you are a driver in a state serviced by the TSA Agent, you may apply online at <http://hazprints.tsa.dhs.gov>, or contact a customer service agent, who can complete the application over the telephone, between 7am-9pm Eastern Monday-Friday at (877) 429-7746.

Expirations:

We take extra steps in ensuring drivers don't forget about their expirations. Notices are sent out to each driver in advance to be able to start our drivers on this process. Drivers must submit this to the Compliance Department prior to expiration.

Medical Renewal: Make sure you make a copy of your long form for us as it can take awhile for the Clinic to send us updates.

Compliance overview:

Compliance Department makes sure their drivers are in good standing with all Federal, state, and local DOT and transportation related regulations.

THE DRIVER MAKES THE DIFFERENCE

Commercial motor vehicle (CMV) drivers are some of the safest drivers on the road. They cause fewer accidents, are more likely to follow the rules, and are less likely to drive while intoxicated than their four wheeler counterparts. Yet almost 5,000 people die every year in crashes involving large trucks, and more than 100,000 are injured, usually occupants of non CMVs. Consider these statistics from 2013:

- For 2 out of 3 passenger-car drivers involved in fatal crashes, driver- related factors like speeding and inattention were noted as possible causes- compared with just over 1 in 3 truck drivers involved in fatal crashes. You can't control other drivers, but you can stay on the defensive, and that can mean the difference between making it home safely and becoming another statistic. Be sure to follow these rules every time you get behind the wheel:

1. Use extreme caution and slow down when hazardous conditions exist. It's YOUR responsibility to operate your vehicle safely and to decide when it's just too dangerous to keep driving.
2. Always wear your seat belt – it's the law! Stay within the speed limits. Use extra caution in construction zones. Remember to drive defensively.
3. See and be seen. Pay attention to what's happening around you – in all directions – and signal your intentions to other drivers.
4. Prepare for the unexpected; follow your smith system training and keep control of your vehicle at all times. Remember that evasive steering harsh braking and leaving the road could cause a roll over event. By following safety rules, driving defensively, and planning for emergencies, you can help avoid becoming – or contributing to – another accident statistic.
