

### **DECISIONS**

Often there are issues that drivers have to overcome while in the field. Decisions like ... Will the load fit? How do you handle an irate customer? What do you do if the customer gives you confusing instruction? What if the tank is not clearly marked?

Drivers sometimes attempt to figure out what needs to happen and make a decision. Often, because we don't have all of the available information, we can make the wrong decision. The only way to be sure you're making the correct decision is to contact dispatch or your immediate supervisor. They have the responsibility of taking your field information and getting the direction from our customer. The right step when you are uncertain is to contact dispatch or your immediate supervisor regarding any questions you may have.



## SAFETY TIPS - Loading & Unloading

There is very little risk involved in handling hazardous materials if you take the necessary precautions each time you load or unload your vehicle. The Do's...

- Keep your vehicle from moving when parked. Set the parking brakes and chock the wheels.
- If loading or unloading a cargo tank, make sure that a "qualified" person is in "attendance".

Note: This person must be alert, be within 25 feet of the tank, a have an obstructed view of the cargo tank and delivery hose to the maximum extent practicable. This person must also know the material's hazards, know appropriate emergency procedures, be authorized to move the tank and be able to do so.

#### The Don'ts...

- Don't smoke on or near a vehicle or carry any flame or a lighted cigar, pipe, or cigarette while loading or unloading explosives, oxidizers, or flammables.
- Don't use tools that could damage tank, or valves.
- Don't load flammable and explosives materials in a cargo space that has a heater unit-unless you follow all related rules.
- Don't load any tank that shows signs of damage or are leaking.
- Flammables-turn off your engine and attach a ground wire. You may run the engine if it is needed to operate a pump.

**Note:** Remember-even, if you are not the one to load your vehicleyou are still responsible for making sure it is done correctly.

### Danger of U Turns

- Roads are not flat; they have slopes and cambers for rain runoff.
- Front trailer axle turntable (pivot point) allows the trailer wheelbase to narrow causing an unstable effect.
- Surge of product is now going sideways causing center of gravity to go sideways while front wheelbase is narrow causing trailer to flip.
- Natural force of inertia is pushing the trailer forward while drawbar is pulling trailer sideways causing whipping effect.
- Almost all rollovers occur below the posted safe turn speed limits.

Remember: Drivers- It's <u>UP</u> to you. You make the decisions that will ultimately prevent a rollover.

# The Trainer's Corner

1.) When loading diesel fuel, remember the compartments are not full to their capacity. Make sure you slow down when turning. The fuel may move from side to side, causing a shifting in weight, resulting in a possible rollover.

- 2.) When assigned to a different truck each day, make sure the crossover valves are closed during your PRETRIP. Also before loading and unloading.
- 3.) Summer time is coming, kids are out of school, watch out for them. This is also the traveling season for families. Please watch for RV's when entering or exiting service stations.




## STAY IN COMPLIANCE.


The new Hours of Service state that you have to take 10 consecutive hours off between shifts in order to be in compliance. Under the old rules you only had to take 8 consecutive hours off. If you do not take the 10 hours off, it com-



bines the previous day to the current day making you in violation for being on duty for more than 14 hours and driving more than 11 hours. Safety is first so make sure you
