#### DO NOT FORGET ABOUT HAZMAT SECURITY

Hazmat transporters have always had the huge responsibility to safely move hazardous materials. Because of increased security concerns, the job of hazmat transporters has become even more important. The knowledge of and compliance with the regulations is now more critical than ever. Any inconsistency or error in a shipment will receive considerable scrutiny and cause considerable delays.

To avoid any problems make sure markings, placards, shipping papers and response information are all in order. In addition to what is required by the Hazardous Materials Regulations the following security precautions are suggested to be taken when transporting hazardous materials:

Follow hazmat routing guidelines and requirements Route away from cities and populated areas when practical Review and improve security measures Contact authorities to report any suspicious activity Do not leave vehicles unattended

Make sure hazmat is in responsible and reliable hands

#### NEW "USA PATRIOT ACT" REQUIREMENTS

To <u>OBTAIN</u> (effective Jan. 1, 2005) or to <u>RENEW</u> (effective May 31, 2005) a Hazardous Materials Endorsement, a driver has to pay (\$94) and pass a criminal background check. To review the entire regulations you may visit the Federal Motor Carrier Safety Administration website at www.fmcsa.dot.gov. # **Company Procedure for Backing Up**

- 1) Get out and look before backing.
- 2) Check the rear of trailer.
- 3) Set out all orange cones at the rear of trailer as a safety area.
- 4) Blow horn before backing
- 5) Back no more than 1 mile per hour.
- 6) Keep your eyes moving.
